

## **Electro-Voice ZLX-12BT Win To Stream Competition (the “Competition”) - Terms and Conditions**

**This Competition is free to enter.**

### **General**

1. By entering the Competition, entrants agree to be bound by these Terms & Conditions (the “**Terms**”).
2. The promoter is Bosch Sicherheitssysteme GmbH, a company incorporated under the laws of the Federal Republic of Germany at Robert-Bosch-Ring 5, 85630 Grasbrunn, Germany (the “**Promoter**” or “**Bosch**”).
3. The Competition is not affiliated with Facebook and is in no way connected with, sponsored or otherwise supported, accompanied or monitored by Instagram and/or Facebook or any subsidiary companies and/or associates. All questions, comments or complaints relating to the Competition should be addressed to the Promoter and not to Facebook.
4. The Competition comprises a single competition conducted over the period specified below, with one first prize winner.
5. The Competition will commence on 08:00 (GMT) on March, 1<sup>st</sup> 2020 (“**Commencement Date**”). The closing date is March, 15<sup>th</sup> 23:59pm (GMT) (“**Closing Date**”) (together the “**Term**”).
6. The Competition is only open to individuals based in selected European countries (full list in appendix 1) aged 18 or over (“**Eligible Participant**” or “**Participant**”). Employees of the Promoter, or of any other company within the Bosch group of companies, and their immediate family members, Bosch’s agents or their employees, or any person professionally associated with this Competition (including owners or employees of any EV Retailer) or members of their family or household are excluded from participating.
7. The Promoter assumes that by entering the Competition (and the Participant warrants that) the Participant is aged 18 or over. Participants entering the Competition as an employee of an organisation have an obligation to (i) inform their employer about the Competition, and (ii) obtain the permission of their employer to enter the Competition.
8. Participation with fake identities or with identities of third parties is not permitted. Automated participation (e.g. via participation and registration services) and multiple participation are not permitted.

### **The Entry**

9. An Eligible Participant will automatically be entered into the Competition if they:
  - a. Like the designated Facebook post called “Win To Stream” (“**Post**”) published by Electro-Voice on Facebook as of March, 1<sup>st</sup> 2020;
  - b. Places a comment underneath the Post and tags it with Electrovoice and Win To Stream on Facebook;
  - c. Shares the Post via Facebook.

(together the “**Entry**”).

10. Each comment that is placed underneath the Post will be assessed by the Promoter's marketing team for its eligibility for entry in the Competition and will approve it provided that:
  - a. it complies with the requirements of these Terms.
11. Any Entry that does not contain the information required pursuant to the Terms will be an invalid Entry and will not be entered into the Competition. The Promoter reserves the right and has complete discretion to disqualify any Entry deemed unsuitable, inappropriate, explicit or offensive, and accepts no responsibility for Entries not successfully or fully completed due to any reason including technical faults. Disqualified entrants will not be informed.
12. Only one Entry can be made per Eligible Participant; additional Entries made by the same Eligible Participant and Entries received after the Closing Date will not be accepted.
13. Participants are not required to purchase an Electro-Voice ZLX-12BT loudspeaker in order to participate in the Competition.

#### **Winner Selection**

14. Following the Closing Date on a date no later than March, 16<sup>th</sup> 2020 (the "**Date of Drawing**"), each Accepted Entry will be collected by the Promoter's marketing team, and the Facebook ID of each Participant will be entered in a spreadsheet. A algorithm will select a random first prize winner (the "**Winner**").
15. The Winner's Facebook ID and Picture will be notified and re-posted by the Promoter on the Promoter's Facebook page. Subject to clause 30, the Winner gives its consent to the Promoter to retweet, like, re-post or otherwise publish their Picture(s) and name, tag or publish their Facebook or Instagram ID with the Picture(s).

#### **The Prize and Notification**

16. The Winner will receive one pair of (2 pieces of loudspeakers) new, boxed Electro-Voice ZLX-12BT loudspeaker (the "**Prize**").
17. The Promoter will identify and notify the Winner within a period of six (6) days from the end of the Date of Drawing. The Winner gives his/her consent to be notified by a post on Instagram and/or Facebook respectively and to be sent a Facebook/Instagram message from the Promoter or another Bosch group company ("**Notification**").
18. The Winner must contact the Promoter within 14 days of the date of the Notification to claim the Prizes and provide the Promoter with their delivery address ("**Winner Confirmation**"). If a Winner fails to claim the Prize, such Winner will forfeit the Prize. In this event, the other Accepted Entries retained in the spreadsheet can be drawn according to clause 14; the process of selecting a new winner will continue until the Promoter receives a valid Winner Confirmation from any subsequent winner.

19. The Promoter will arrange for the Prize to be delivered to the Winner at the Promoter's cost. Please allow up to 28 days from the Winner(s) Confirmation for delivery of the Prize.

#### **Other important information**

20. The Prizes are not transferable and there is no cash alternative. The Promoter reserves the right to substitute any or all of the Prizes with a prize of equal or greater value at any time.
21. In all matters relating to the Competition, the decision of the Promoter shall be final and no correspondence or discussion shall be entered into.
22. (1) A violation of these Terms and Conditions entitles the Promoter to exclude the respective Participant from Participation. This applies in particular if the participant makes false statements or if contents (e.g. comments) violate applicable law, the rights of third parties or the rights of the Promoter. The same applies to comments that may be considered glorifying violence, offensive, harassing or degrading, or that otherwise violate social decency.  
(2) If the excluded participant is a Winner who has already been drawn, the prize can be subsequently withdrawn.
23. The Promoter reserves the right to amend or terminate the Competition at any time without notice. Any termination or amendment to the Competition will be communicated in the same way as the Competition was communicated.
24. The Competition cannot be used in conjunction with any other promotions that are run by the Promoter or any company within the Bosch group of companies.
25. The Promoter excludes all liability for taxes relating to Prize and any tax liability arising from the provision of the Prize will be the sole responsibility of the Winner of the Prize.
26. The Promoter does not claim any rights of ownership in your Entry, nor does the Promoter accept responsibility for the return of any Entry, including those consisting of artistic or other material.

Insofar as personal data of Participants is collected, processed and used within the scope of the competition, it will be collected, processed and used by Bosch Sicherheitssysteme GmbH exclusively for the purpose of carrying out the Competition and deleted after the Competition has ended. All data will be deleted at the latest 30 days after the end of the Competition. Address data will only be collected from the Winner and Winners and will be used to transmit the prize. No data will be passed on to third parties, unless this is necessary for the execution of the Competition. Participants are entitled to statutory rights of information, amendment and revocation. By participating in the Competition, the participant agrees to the storage and use of the data by Bosch

Sicherheitssysteme GmbH for the above-mentioned purposes. The participant has the right to object to the use of the data at any time. In this case the data will be deleted immediately. By entering, you agree to release and hold harmless the Promoter and its group companies, subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from such Participant's participation in the Competition and/or his/her acceptance, possession, use, or misuse of the Prize or any portion thereof.
31. Should a clause of these Terms and Conditions be invalid, the validity of the remaining clauses remains unaffected.
32. The Competition will be governed by the laws of Germany.
